The West Berkshire District Council (Newbury Town Centre)
Public Spaces Protection Order 2021

West Berkshire District Council ("the Council") has made the following Public Spaces Protection Order under section 59 of the Anti-Social Behaviour, Crime and Policing Act 2014 ("the Act") and this Order shall come into operation on the 1st day of February 2021. The Council having been satisfied on reasonable grounds that activities carried out in the public space within the Council's area have had a detrimental effect on the quality of life of those in the locality or it is likely that activities will be carried on in a public space within that area and the effect or likely effect of these activities is likely to be of a persistent or continuing nature, or is likely to be such as to make the activities unreasonable and the effect justifies the restrictions imposed. The activities include persons behaving in a manner that has caused or is likely to cause, nuisance, harassment, alarm or distress and persons being intoxicated and behaving in a manner that has caused or is likely to cause nuisance or disorder.

1. This Order relates to Newbury Town Centre as shown edged in red on the map attached (the "Restricted Area") being land in the area of the Council which is land to which the Anti-Social Behaviour, Crime and Policing Act 2014 applies and will be protected by the making of this Order.
2. The Order may be cited as the West Berkshire District Council (Newbury Town Centre) Public Spaces Protection Order 2021 and shall come into force on 1st February 2021 for a duration of 3 years.
3. The effect of this Order is that any person is prohibited as described in (a) and (b) below and will be required to do the following actions within the Restricted Area:-
 - a) any person behaving in a manner that has caused, or is likely to cause, nuisance, harassment, alarm or distress must leave the Restricted Area when requested to do so by an authorised officer for a specified time, and not return to that area for a period not exceeding 24 hours
 - b) any person must stop drinking and hand over any containers (sealed or unsealed), which are believed to contain alcohol when required to do so by an authorised officer to prevent nuisance or disorder.
4. An authorised officer, as referred to in paragraph 3 of this Order, includes a constable, namely a police officer and a police community support officer or a person who has been authorised for this purpose by the Council.
5. Any person who fails to comply with this requirement in paragraph 3 (a) of this Order, under section 67 of the Act is liable on summary conviction to a fine not exceeding level 3 on the standard scale or a fixed penalty notice to a maximum of £100.
6. A person who fails to comply with this requirement in paragraph 3 (b) of this Order, under section 63 of the Act is liable on summary conviction to a fine not exceeding level 2 on the standard scale or a fixed penalty notice to a maximum of £100.
7. If any person desires to question the validity of this Order on the grounds that the Council had no power to make it or that any requirement of the Act has not been complied with in relation to this Order, he or she may apply to the High Court within six weeks from the date on which this Order is made.





Newbury PSPO 'Restricted Area'

Newbury PSPO 'Restricted Area' borders and includes the A339 from Robin Hood roundabout to the junction with Station Road, Station Road, Bartholomew Street, Craven Road, Oddfellows Road, West Mills, Northcroft Lane, West Street, Strawberry Hill,

Oxford Street and London Road. Including: Inches Yard, Newbury bus Station, Newbury library, Newbury railway station, Parkway Shopping Centre, The Arcade, Kennet Shopping Centre, Victoria Park, Weavers Walk, West Berkshire Council Offices West Street House and West Berkshire Council Market Street offices.

Roads/streets within the area: A339 (from Robin Hood roundabout to Station Road), Albert Road, Bear Lane, Carnegie Road, Charlton Place, Cheap Street, Craven Road, East Street, Highfield Avenue, Kings Road West, London Road (from Robin Hood roundabout merging into Oxford Street to the junction with Strawberry Hill), Mansion House, Market Place, Market Street, Marsh Lane, Mayors Lane, Middle Street, Northbrook Street, Northcroft Lane (from Northbrook Street to Northcroft Lane West Car Park), Park End, Park Lane, Park Street, Park Way, Pembroke Road, Station Road (junction of Bartholomew Street to Greenham Road), St Marys Place, St Mary's Road, Strawberry Hill, Swan Court, Victoria Gardens, Wharf Road, Wharf Street, West Mills, West Street, Winchcombe Road to A339.
